



## Veterans Aid and Attendance Benefit

ARE YOU ELIGIBLE?

As a Veteran, you made sacrifices in support of your country. You were there when you were needed. If you need a little help now, Right at Home would like to be there for you and make sure our nation's Veterans get the benefits they deserve. Your local Right at Home office can put you in touch with an accredited claim representative that can help you successfully apply for this benefit.



## What is the Veterans Aid and Attendance Benefit?

Aid and Attendance (A&A) is a benefit paid in addition to monthly pension that may already be received. Benefits may be available for Veterans and surviving spouses who require the regular attendance of another person to assist in bathing, dressing, meal preparation, medication monitoring or other various activities of daily living.

## How Can These Benefits Help Someone?

Aid and Attendance can help pay for care in the home, skilled nursing facility, personal care home or an assisted living community. The amounts listed below are maximum benefit amounts; actual amounts may vary based on Veteran eligibility. The Maximum Annual Pension Rate for 2015 is:

Single Veteran	\$21,466
Married Veteran	\$25,448
Surviving Spouse	\$13,794

## **The Qualifying Periods of War Are:**

<b>War or Conflict</b>	<b>Beginning &amp; Ending Dates</b>
World War II	12/7/1941-12/31/1946
Korean Conflict	6/27/1950-1/31/1955
Vietnam Era	8/05/1964-5/07/1975 (2/28/1961-5/07/1975 for Veterans who served "in country" before 8/05/1964)
Gulf War	8/02/1990 through a date to be set by law or Presidential Proclamation (with 24 months of active service).

## **How do I find out if I am eligible and apply?**

Application for the Aid and Attendance benefit can be complex and require specific financial and medical information; often times the process can take months for approval. Right at Home personnel cannot help Veterans determine eligibility or complete application paperwork but can act as a trusted source for information and no-cost referral for assistance. Call your local Right at Home office and if warranted, they will put you in touch with an accredited claim representative that can help with the process.

## **Who is Eligible?**

- Any War Veteran with 90 days of active duty with at least one day during active War time is eligible.
- A surviving spouse of a War Veteran may be eligible; specific rules do apply.
- Medical, service and financial qualifications must be met.
